## FIRE BENEFIT CHARGE REVIEW BOARD HEARING:

At 6:00 PM, Commissioner Parsons opened the Benefit Charge Appeals Review Board Hearing and read the following statement:

"The King County Fire District #40 Board of Commissioners hereby convenes as the Benefit Charge Review Board pursuant to RCW .52.18.070. The Review Board is authorized to review property owner petitions for adjustment of the benefit charge imposed on their property when such petitions have been timely submitted in writing. The Board may adjust the charge to a true, fair, and just amount if the Board determines that a property owner has been charged too large a sum. The Review Board will remain convened until February 27, 2025. The Review Board will hold two public hearings to receive petitions, the first being today and the second being February 27, 2025. The deadline for submitting petitions challenging the benefit charge was February 1, 2025 at 4:30 PM."

Deputy Chief Sean Penwell was introduced, and he gave a PowerPoint presentation on the 2025 Benefit Charge, reporting that there are no current petitions. The hearing was recessed until February 27, 2025 at 6:00 PM.
