The Review Board is authorized to review property owner petitions for adjustment of the benefit charge imposed on their property when such petitions have been timely submitted in writing. The deadline for submitting petitions challenging the benefit charge was February 1, 2025 at 4:30 PM.

"The Board may adjust the charge to a true fair and just amount if the Board determines that a property owner has been charged too large a sum. This is the second hearing provided by the Board."

Deputy Chief Penwell reported that there no petitions for 2025.

It was Moved by Commissioner Parsons to approve all Administrative Actions (error corrections and discounts) as delegated to staff by the Benefit Charge Review Board. Commissioner Sartnurak seconded. No discussion. Motion Approved (5-0).
